



Dear Applicant:

Thank you for your desire to send your child to Fair Haven Camps. We are pleased to be able to provide scholarships. Due to the large number of applicants for camp scholarships, we are cannot guarantee you will be awarded a scholarship. Our intent is that these scholarships benefit children who are not able to pay for and attend even a single week of camp.

Due to our limited scholarship fund, applicants for multiple children within the same family will be subject to a tiered funding method. The first eligible camper in the family will receive the largest scholarship, subsequent scholarship offers will be less within the same family.

Each family is required to help with the camper registration. Please supply the amount that your family will be contributing. The minimum family contribution is \$50 per child for the non-refundable processing fee. When awarded a scholarship, the \$50 becomes the non-refundable deposit for a week of traditional camp.

Scholarships can only be applied towards Registration. If you switch weeks – the difference will not be refunded or used for store or other activities. If there are openings in a specialty camp, then you must pay the difference between the awarded scholarship and the specialty camp registration fee to attend.

Incomplete applications will not be processed until ALL FORMS AND FEES are received and signed correctly. Scholarships will be awarded on a first come – first served basis in the order they are received, with priority given to first time campers.

If you send in an application and qualify, but funds are not available, your name will be placed on a waiting list to receive a scholarship as funds become available. Scholarship funds are raised through fundraisers and financial gifts from individuals, churches, and businesses.

We look forward to obtaining your completed application and having your child here at camp this summer!
